### **SUBDIVISION/PARCEL LINE ADJUSTMENTS:**

### A. Reid Eberley – Tax #49-000-2-2 (2 lot subdivision), River Road

Mr. Miga was present with a copy of a survey map of the property (35 acres) that had been gifted to Mr. Eberley's children. There is some confusion now whether the remaining 70 - 90 acres are going to be purchased by Mr. Carbone, for the purpose of keeping it "Forever Wild". However, there is the possibility that Mr. Eberley could sell it to NYS, also with the forever wild option, if Mr. Carbone does not purchase it.

Written documentation is still needed stating "forever wild" from one of the parties involved in the waiver request. Another option would be for Mr. Eberley to go forth with the subdivision process. Mr. Miga will be in contact with Mr. Carbone and Mr. Eberley to see how they wish to handle this situation and requested time to get back to us.

The Town Supervisor agreed to our request.

#### **NEW BUSINESS:**

Discussion took place regarding the tax search certificate requirement, now being enforced by the county before filing a new subdivision map. There is a fee of \$20. The board decided the best way to handle this step, is to add this requirement to the subdivision procedure and have the owner present the tax search certificate when they present their final maps to the board for approval and stamping. This change will need to be written in the Subdivision Law and a public hearing will need to be held.

## **Open Discussion:**

The wavier option in the Subdivision Law was discussed and it seems to be unclear as to the exact criteria needed to grant a waiver, as it is written. Co-Chairwoman Ritter stated she would check with the Tug Hill Commission, the county Planning Board and possibly surrounding towns as to whether they have this option in their law and if so, what their criteria is for granting a waiver.

The secretary, brought forth the suggestion that the Co-Chairperson be granted the right to stamp and sign approved subdivision maps, in the absence of the Chairman, to avoid any delay in the filing procedure.

The board agreed that all items in New Business and Open Discussion should be presented at one public hearing.
