Reference made to executive meeting of April 21,2010

Removal of current assessor for insubordination and malfeasance of office. An offer was made to buy her contract She declined the offer. Supervisor met with the Town Lawyer and then made a second offer, this she turned down unsure of when she wanted to resign her station. The assessor may have to be suspended until she is removed from office. There will be an assessor for the interterm.

Supervisor William Hasenauer informed the people of Forestport that they need to keep their appointments with the assessor in regards to their assessments. They will need to follow the process with the Grievance Board if dissatisfied with the assessment presented to them by the assessor. The next step will be small claims court. [These are the steps of process of assessment].

Supervisor William Hasenauer informed the people of Forestport that there is a resolution in place to remove the Town assessor on the grounds of insubordination and malfeasance of office. The Resolution reads.

Be It Resolved that the Town Board of Forestport institutes a proceeding pursuant to Section 324 of the Real property Tax Law to seek removal of the Town Assessor on the grounds of insubordination and malfeasance of office.

And furthermore direct the Supervisor to execute all aspects of said resolution.

Answer. Because she has a 6 year contract


Question. What if we are unhappy with our assessment?




