PUBLIC COMMENTS:

Supervisor Hasenauer opened the commentary by asking if anyone present had any objections to the closure of Maple Road in White Lake for the White Lake Inn's 20th Anniversary on June 2, 2012.

Frank Fellone of the White Lake Shores Association stated that they are concerned about patron of the celebration trespassing on their beach directly across from the White Lake Inn. Additionally, Mr. Fellone stated that parking is also a concern. He inquired as to whether Brian Albert has a plan in place to deal with these issues.

Mr. Albert stated that he did not have a plan to specifically address these issues, but he had contacted the Woodgate Fire Department and the Oneida County Sheriff's Office. Both will be on standby in the event of an emergency. He also said he would do his best to ensure that patrons will not trespass on the Shores' beach. Discussion took place within the gallery.

Supervisor Hasenauer stated that the Town Board is only hearing comments regarding the actual road closure. He suggested Mr. Fellone contact the Sheriff's Office if there is a problem with trespassing and/or parking as there are laws in place to discourage these behaviors. He also suggested that Mr. Fellone and Mr. Albert work together to implement a plan to deal with any issues arising from the celebration. The two agreed to work out a plan.

ADJOURNMENT:
