INFORMATIONAL SPEAKER:

Mary Luker of Gilroy, Kernan & Gilroy presented possible options for town employee health benefits. Mrs. Luker stated that she, Councilwoman Kardash and Supervisor Hasenauer are in the process of reviewing different health plans in the interest of saving the town money on employee health benefits. Councilwoman Kardash stated that changes to the employee health plan could save the town anywhere from 35,000-50,000 annually. Mrs. Luker added that September 2012 is the tentative date for the Town Board to choose a new plan as that is when the budget process begins.
