Don Frank of the gallery spoke of a Quonset structure that was put up in the Town of Forestport. He stated that these structures are very ugly to look at and would like the board to pass a law against being able to put up these structures in an open area for all the public to view. Supervisor Hasenauer stated the board would look into this matter. Mr. Frank thanked the board for any attention given to this matter.

Greg Albright from the gallery asked if the town would plow the county parking lots and the snowmobile clubhouse because the club's plow is broken. Supervisor Hasenauer replied that it is not the town's responsibility so they will need to fix their plow.

Dawn Campbell informed the board that the November board meeting falls on the night before Thanksgiving. The board agreed to move the meeting date to November 19, 2012 at 6:30pm.

Supervisor Hasenauer informed the board that he and some of the town employees met with Time Warner Cable regarding the computer system at the town hall. The town's tech guy, Ian, was also present for the meeting. Supervisor Hasenauer stated that our current system with Frontier in not working properly therefore we need to look at other options to save the town money. Time Warner

will put together a quote to be brought before the board.

The town board entered into executive session at 7:13pm regarding a specific personnel matter and a water district issue.

The board returned from executive session at 7:38pm with no action taken.
