The meeting was called to order at 6:30 pm by Deputy Supervisor John Isley. The Pledge of Allegiance was recited.

BID CONTRACT AWARDING AND SIGNING:

Deputy Isley stated that the town received a low bid of \$606,324.00 from Bell Construction Company for the Twin Bridge Project.

Attorney Riley reviewed the Construction Contract and in his opinion everything looked good and could be signed by the Town Supervisor.

A motion was made by Councilman Robert Seager and seconded by Councilwoman Joanne Kwasniewski to enter into contract with Bell Construction for the Twin Bridge Replacement Project. Roll call vote:

Supervisor Hasenauer signed three copies of the contract at this time.

TRANSFER OF MONEY:

Deputy Supervisor Isley stated the transfer of money will be done at the offices' of Hancock and Estabrook on April 3, 2013 at 11:00am. The money will be electronically transferred to the highway checking account at Adirondack Bank.

CHANGE ORDERS:

Discussion took place regarding reducing the asphalt top course thickness from 2" to $1 \frac{1}{2}$ " as stated in line #1 of Change Order #1. The board agreed that keeping the asphalt top course thickness at 2" would help maintain the roads due to snowmobile traffic.

A motion was made by Councilwoman Joanne Kwasniewski and seconded by Councilman William Karn to keep the asphalt top course thickness at 2" and delete item #1 from Change Order #1. Roll call vote:

Keeping the asphalt top course thickness at 2" adds \$1700.00 to the contract sum of \$556,324.00. The new contract sum including this amended Change Order is \$558,024.00.

Roll call vote: Councilman Robert Seager- yes Councilwoman Nancy Kardash - yes Councilwoman Joanne Kwasniewski - yes Councilman William Karn - yes Supervisor William Hasenauer – yes Deputy Supervisor John Isley- abstained

Supervisor Hasenauer signed three copies of said Change Order at this time.

CLERK OF THE WORKS:

Deputy Isley reported that there are three proposals for Clerk of the Works.

- 1. Steven Zarnoch, part-time at \$28.00 per hour
- 2. David Facchini, part-time at \$75.00 per hour
- 3. James Jordan, \$25.00 per hour

Discussion took place regarding the need for a Clerk of the Works.

A motion was made by Councilman Robert Seager and seconded by Councilman William Karn to hire Steven Zarnoch as Clerk of the Works for the Twin Bridge Project. Roll call vote:
