NOCOGG:

Gerry Ritter reported:

- If the town has any projects they would like to get a grant for, the deadline for submitting a Consolidated Funding application is August 12, 2013.
- The State Comptroller's Office recommends that the town conducts an in-house risk assessment to address security and information technology vulnerability and security.

Gerry stated that the town should pick a tree vendor as soon as possible for the tree grant. Jennifer Hartsig reported that according to the tree grant the town has to reach out to a least three tree vendors before deciding which vendor to go with. This has been achieved (Greenscapes, Coldwell's and Olney's) so the board should make a decision and pick a vendor. The vendor must guarantee the trees and plant approved trees. Discussion followed.

PLANNING AND CODES:

Supervisor Hasenauer inquired as to why Mr. Kranbuhl has to bring his private road up to town specifications before he is able to subdivide his property. Supervisor Hasenauer does not agree with this because it is a private road that is off of a seasonal town road. Planning Board Chairman Don Graff stated that according to the town's current Subdivision Law, any lands that are subdivided on a private road, the applicant must bring the private road up to town specifications. Mr. Graff stated that the Planning Board must follow and administer the Subdivision Law. Discussion followed regarding development of subdivisions.
