CALL TO ORDER:

The meeting was called to order at 7:00 pm by Supervisor Hasenauer.

TOWN CLERK MINUTES:

Councilwoman Kardash stated that she has some concerns regarding the proposed fee structure. She feels that some of the fees are high (new construction, covered porch, boathouse and garages) and would like to see docks removed from the fee structure. Councilman Seager stated that he does not agree with the proposed fee structure and would like the old fees to be reinstated (\$25/\$20). Councilman Karn also stated that he is not in favor of the proposed fees and questions who will administer this process. Councilwoman Kwasniewski would like to see recreational vehicle and renovation of existing square footage removed from the fee structure. Discussion followed.

Supervisor Hasenauer stated that the Town Board needs to make a resolution to form an Appeals Board for Flood Damage Prevention.

Discussion followed regarding the type of tree to plant and when to plant them. The board will decide later in the meeting if they choose Robinson's for the purchase of the trees.
