#### **CALL TO ORDER:**

The meeting was called to order at 6:54 pm by Supervisor Hasenauer. He stated the meeting would open with business from the public as there were several matters before the board. They went as follows:

## Mr. and Mrs. Tom Iacovissi – Request for a Variance Hearing

Mr. And Mrs. Iacovissi have purchased property on the McKoon Rd. They would like to build an 800 square foot cabin with full walkout basement for mechanical purposes. The Planning Board has referred them to the Town Board for a variance as the proposed building plan situates the cabin off the pre-existing footprint.

# • Jeanie Wolcott – Request for Zumba classes

Mrs. Wolcott approached the board regarding Zumba classes in the Town Hall. She stated she has been asked to fill in for the current instructor who is unable to teach the classes currently. She reported that she is licensed and insured.

The board had no problem with her proposal, but did state Mrs. Wolcott should check with Mrs. Jenny so as to be under the terms of her current contract with the Town. Dawn Campbell will review the contract to see when it expires.

## • Joseph Detraglia – Codes violations at 5167 Elmwood Road

Mr. Detraglia stated that the property is and has been in disrepair for some time and is a detriment to the character of the neighborhood. He inquired as to the status of the complaint filed in regard to the property.

CEO Brad Smith stated that he has visited the property and a summons has been issued for the appropriate parties to appear in court to answer the complaint on October 15<sup>th</sup> at 3:00 PM.

Supervisor Hasenauer thanked Mr. Detraglia and assured him the town will follow through with the complaint.

## • Tim Schumaker – Alleged codes violation at property bordering Elmwood and Alder Road

Mr. Schumaker stated that he has been told his property is in violation of the Site Review Law in regard to the number of campers on the lot. He reported that the lot is used as a summer vacation spot for his family, both campers are registered and insured, and are linked to a viable septic system on the property. Additionally, both campers are removed for the winter season.

Councilman Robert Seager inquired as to the number of sleeping areas in the campers and the specifications of the septic system. Mr. Schumaker stated there is one bedroom in each camper, and the septic system is a concrete 1000 gallon tank with an appropriate leach field. Councilman Seager reported that the system is designed for a three bedroom home and therefore Mr. Schumaker is within the parameters of the Site Review Law.

# • Brian Albert- Proposed Gas Tank at White Lake Inn

Mr. Albert stated he applied for a building permit for a 500 gallon gas tank for the purpose of retailing fuel to snowmobiles and boats at his place of business. He reported

he has received APA approval as well as DEC approval, yet his application remains incomplete as per the Planning Board pending a SEQR review. His understanding is that a SEQR is not required due to the size of the tank.
