CALL TO ORDER:

The meeting was called to order at 6:43 pm by Supervisor Hasenauer.

EXECUTIVE SESSION:

AMENDMENT TO LEASE AGREEMENT WITH OPTION TO PURCHASE DATED AUGUST 21, 2012

WHEREAS, the parties entered into a lease agreement dated August 21, 2012, relating to the premises at 11917 North Lake Road, Forestport, New York and now wishes to make changes or amendments to the agreement to extend the term of the agreement for one year and to increase the option purchase price by Five Thousand Dollars (\$5,000.00).

NOW THEREFORE, in consideration of the mutual promises and covenants herein contained, the parties hereto hereby agree that the lease agreement dated August 21, 2012, by and between the parties, be amended as follows:

- Paragraph 2 of the Agreement be amended to read as follows:
 Term: The term of this lease shall be for three (3) years commencing on September 1, 2012 and ending three (3) years from that date.
- 2. Paragraph 4 of the Agreement be amended to read as follows:

 Option to Purchase: During the term of this lease, Randall shall have the option to purchase the leased property at any time for the purchase price of Sixty-Four Thousand Dollars (\$64,000.00). If the option to purchase is exercised during the three (3) year term of this lease, the rental payments set forth in Paragraph 3 hereof shall be applied to the purchase price.
- 3. That all of the terms and conditions of the lease agreement dated August 21, 2012, by and between the parties shall remain in full force and effect.

Supervisor Hasenauer stated that whoever wins the bid will have to apply to the Planning and Codes Office for a permit.

Councilwoman Kwasniewski stated that she has spoken with Recreational Director Sonja Skidmore regarding raising the price for senior trips. Ms. Skidmore doesn't believe it is a good idea to increase this amount. Ms. Skidmore and Councilwoman Kwasniewski feel that if the senior tour bus has pick-up's in Otter Lake and in the village this will encourage more seniors to attend the trips. Ms. Skidmore is also going to plan less expensive senior trips to keep the overall cost to the town down.
