**WHEREAS**, the Town of Forestport has proposed this local law to amend the Town of Forestport Site Review Law; and

**WHEREAS**, it is the principal purpose of this local law to provide an appeal process whereby the Town Board can grant variances from certain provisions of the Site Review Law; and

**WHEREAS,** a notice of public hearing was duly given to the public of this proposed local law and on February 5, 2014, a public hearing was held thereon at which time the proposed amendments to the Site Review Law were presented in a red-line version of the Site Review Law showing all amendments in red type face which this local law makes to the Site Review Law; and

WHEREAS, the Town Board's authority for passing this local law is set forth in Municipal Home Rule Law Section 10, Subdivision (ii)(d)(3) which provides a Town Board may amend or supercede any provision of the Town Law relating to the property, affairs or government of the Town or other matters in relation to which and to the extent to which it is authorized to adopt local laws notwithstanding that such provisions of the Town Law is a general law;
