Supervisor Snead reported that the sewer beds are not draining properly and he feels that they will need to be replaced in about a year. Discussion followed.

Code Enforcement Officer Brad Smith stated that he and Supervisor Snead have been in discussion with Town Engineer Jack Dodson about the possibility of adding another hook up to the sewer pipe line. The reason for this discussion is that there is a noncompliant private sewer system located at the old rectory. Discussion followed regarding the financial aspects of adding another customer to the sewer district.
