CALL TO ORDER:

The meeting was called to order at 6:30 pm by Supervisor Snead.

PLEDGE OF ALLIGENCE:

Recited.

EXECUTIVE SESSION:

A motion was made by Councilwoman Kardash and seconded by Supervisor Snead to retire to Executive Session at 6:31pm for a personnel matter. Roll call vote:

The board returned from Executive Session at 6:55 pm with no action taken.

NEW BUSINESS (Board):

Supervisor Snead began a brief review of the lawsuits currently pending against the town. Councilwoman Kardash stated that it was not appropriate to discuss pending litigation.

Supervisor Snead reviewed the status of the DOT project on the Dustin Road Bridge. The bridge work will go out to bid in the fall and be constructed over the summer in 2016 at no cost to the towns of Remsen or Forestport.

He additionally reported that Ian Joseph of TKE Systems will install the new firewall of the town computer network sometime next week.

OLD BUSINESS (BOARD):

Supervisor Snead stated the Town Attorney Earl wishes to review the Employee Handbook draft with the board to address some civil service language which does not apply to Forestport. The vote to approve the handbook will be tabled pending a workshop to address the changes.

A motion was made by Councilman Scouten and seconded by Supervisor Snead to deny the Northern Oneida County ATV Club's request to open a section of Buck Lake Road from Abb's Corners to Round Lake Road. Roll call vote:

Councilwoman Kardash stated that the healthcare handbook for employees needs review, and that it should be done in concert with the employee handbook at a workshop. A tentative date of March 4th was scheduled with a time TBD.

Councilwoman Kardash additionally inquired into the status of the North Lake Road property currently being leased to Ray Randall. Supervisor Snead stated that Ted Earl has reviewed the lease and deemed it too weak to evict Mr. Randall for reasonable legal expenses.

She additionally inquired into the status of the town historian position. The

reappointment of Walter Paprock was tabled at the Organizational meeting in January pending further review of the job description by the board. Mr. Paprock was in attendance and gave a report on his typical activities within the position. He and Supervisor Snead agreed to meet in order to discuss the matter further. Councilwoman Kardash apologized to Mr. Paprock on behalf of the board for the lapse in communication with him in this matter.

David Ultsch of the gallery advised the board that it is customary for an elected official to appoint themselves to paid administrative leave when sexual harassment allegations have been levied, pending the outcome either criminally or civilly. He asked Supervisor Snead if he planned to do so, and discussion ensued. Supervisor Snead stated he is innocent, and is not going to step down. Mr. Ultsch asked the board if they planned to remove Supervisor Snead with a vote, but no one from the board moved to do so. He reminded the board that without action, the board members could be responsible for possible future actions.

Maggie Peterson of the gallery asked Supervisor Snead if Ted Earl or any other attorney from Felt Evans Group ever personally represented him (Mr. Snead) or his wife Joan. Supervisor Snead replied that he has never been personally represented by anyone within the Felt Evans Group. Supervisor Snead also stated that his wife was, at one point, represented by an attorney from Felt Evans.
