Mr. And Mrs. Sbarra of Walnut Road stated that they have discussed the matter with others in the neighborhood, and many are against this idea. Supervisor Snead stated if this is the case then the town will not move forward.

A gentleman from the gallery commented that the boat launches and town hall are looking very nice. He also stated that he would like speed limit and children at play signs put up on Irish Settlement Road. Supervisor Snead directed him to contact Highway Superintendent Bill Gardner.

Pat Holt of Elmwood Road stated her concerns regarding the intersection of Elmwood and Walnut Roads. The "cut through" area of the intersection is no longer available to the public due to the guardrails in place. Additionally, she had concerns regarding missing stop signs in the area. The board stated they will investigate the ownership of the parcel, and report back. Councilwoman Kardash also stated Bill Gardner has stop signs on order for the intersections in that area. Discussion took place.

Art Gleasman approached the board regarding a budget request for improvements to the Village Park. The former American Legion members are contributing money towards some landscaping and would like the town to bear the cost of the lawn treatments for 2016.

A motion was made by Councilwoman Kwasniewski and seconded by Councilwoman Kardash to approve the budget request of approximately \$750 for the lawn treatments. Roll call vote:

Chief Jeff Abrial of the Otter Lake Fire Department inquired if the board had made any progress on the budget request the department made at the July meeting. Supervisor Snead stated they will address the request at budget time. Some discussion followed.
