OLD BUSINESS BOARD:

1. Medical Insurance

Deputy Supervisor Joanne Kwasniewski brought forward and read into the minutes the following resolution concerning the November 2014 Medical Insurance Guidelines:

"On November 19, 2014 this board unanimously passed a resolution stating that "the minimum salary amount for health care eligibility" was \$10,000.00 Section 4.7 of the Employee Handbook adopted by the board at its April, 2015 meeting, states that "full time employees are eligible to join the town's group health insurance plan". The plan overview in the Excellus Group Health Care Plan effective January 1, 2015 states that "you are eligible for benefit programs shown on Schedule "A" if you are a full time active employee normally scheduled to work 30 hours per week". These statements of eligibility need clarification and amplification because they do not explain coverages for elected officials and do not contain a statement concerning the limitation on the Town's share of health care premiums.

Upon motion made by	and seconded by
	effective January 1, 2016 it is resolved that;

- (1) Full time employees and elected officials of the Town making less than \$10,000.00 are not eligible to join the town's group health plan;
- (2) The Town will contribute up to and no more than \$600.00/month toward the health care premium coverage of each eligible full time employee and each eligible elected official;
- (3) Section 4.7 of the employee handbook and the Excellus Plan overview will be amended to reflect these revised standards and Town contribution limits."

Councilman Charles Scott asked if current elected officials are grandfathered in and would be changed as the position occupancy changes. Deputy Supervisor Joanne Kwasniewski answered that current elected officials can't have insurance taken away. She asked Ted Earl if this resolution needs revising. He answered, no that's different;

and the main purpose of this resolution is to address the 2016 Budget changes and the new health care plan that goes into effect.
