- September 29th, there will be an Annual Dinner at the Delta Lake Inn. To cut the costs, they will be doing an email blast and sending out fewer paper invitations.

SUPERVISOR'S REPORT:

OLD BUSINESS BOARD:

- NYMIR renewal: All paperwork has been signed. They need to do a Building Reassessment. Highway Superintendent William Gardner and Dorothy did a lot of updating as to what is currently owned.
- ATV Local Law: This has been put on hold until next month. It is still being worked on by the Attorney's office.
- Summer Recreation Program:
 - The Town had the exact number of Counselors, but then a couple were unable to do it. At that point it was too late to run the Program smoothly due to lack of staffing.
- Unsafe Buildings Law: Supervisor Entwistle stated this Law doesn't mean they will be tearing down every building. This is only to be used as a tool if it's deemed necessary. This will cut the costs the town generally incurs when it has to be taken to court.

• Highway Contract: The next meeting is scheduled for August 18th at 4:30. The negotiations are going really well. Hopefully by then there will be a tentative agreement.

- Trash Days Report: Trash days went well. Even though there was an accident on Route 28, residents were rerouted to trash day location through Boonville. The road was cleared around 12pm.
- Fireworks: The Town has a budget for \$1500 for the fireworks. For several years, Majestic has been asking for \$2100. Supervisor Entwistle stated he is willing to pay the amount this year, but will speak to Jeanne Wolcott about how to come up with the remaining monies for fireworks in the future.
