- Dry Hydrants- Supervisor Entwistle is going to touch base with the DEC because some are on the river bank and they need to be involved. Since they installed them they can possibly fix the ones that are broken. All the dry hydrants in the Forestport district are fitted with 6 inch fittings.
- Dump Day- July 15th from 8am-4pm.
- Community Shred day July 22 from 9am-1pm. This is free for the community.

NEW BUSINESS BOARD:
