NOCCOG:

- January 25, 2017 is a training in the Town of Trenton for Newly elected officials. Any municipal person can attend.
- The Town is eligible for one free ticket to the March conference.
- The NOCCOG Commissioner has passed away. Sue informed the Board of a celebration of life everyone was invited to.

OLD BUSINESS BOARD:

- Horton Road Bridge: Bill Gardner and Supervisor Entwistle met with different agencies. The Bridge is scheduled for 2020 and bids will start going out in the Fall of 2019. An Engineer has been selected. Supervisor Entwistle and Bill Gardner did request that once they begin construction that they do it smoothly without a lot of change orders. There has not been a firm bid from the engineers as of yet. Environmental studies have to be done at this point. There are endangered bats and they can only be checked during April 1 and June. A lot of areas have river mussels and caution needs to be taken as to not cross contaminate. Councilman Scouten asked if there would be an access point. Supervisor Entwistle stated they may try to raise the bridge a little.
- Records Grant: Supervisor Entwistle met with Jen Piper yesterday. The Grant will include the Supervisor's office, Tonya's records and some Town Clerk's records.
- Tech Services: The Town will be using Total Solutions for services. They will be

coming tomorrow to hardwire the board. Once it is all set up, they will get a constant update by email.

• The Contract with TKE Systems was supposed to have a years' notice before termination. Ian asked Supervisor Entwistle to pay the first quarter instead of the whole year.

A motion was made by Councilman Rockhill and seconded by Councilman Scott to pay TKE Systems, Inc. \$2,640.00 to satisfy the one year's notice. Roll Call vote:

• Payroll Service: This should be up and running properly smoothly by this pay period, if not by the next.

NEW BUSINESS BOARD:

- Twin Bridges Loan: Supervisor Entwistle thanked Bill Gardner, Highway Superintendent for taking a couple thousand off the loan. There is \$100,000 put aside for a payment on the loan. If the Town stays with the BAN, they will be locked in for 20 more years. The deadline is March 1st. Supervisor Entwistle and Dawn Campbell have discussed this and they would like to have Adirondack Bank give them an anticipation note rate of 2.8%. This allows the flexibility to crank up the payment if there is enough money. \$328,000 is owed right now. Councilman Rockhill suggested getting an anticipation note for the entire \$328,000. Supervisor Entwistle will be doing more research and getting the current interest rates.
- Town Fuel Provider: Bill Gardner, the Highway Superintendent is interested in switching Fuel Providers from Buell Fuels to Halpin's Fuel. Supervisor Entwistle read a proposal from Tim Halpin. Supervisor Entwistle asked Tracy Northrop, The Town Clerk to make sure there isn't a contract with Buell Fuels.

A motion was made by Councilman Rockhill and seconded by Councilman Scouten to terminate with Remsen Buell Fuels and write up a contract with Halpin's Fuel. Roll Call Vote:
