The Board tentatively plans to run the STEM Program again, along with two trips to McCauley Mountain for skiing, possible golf lessons, outdoor movie nights and movies for Seniors.
- Woodhull Bridge Update: The County started the Bridge on September 4th and will continue for around 70 days.
- Minimum Maintenance Road: The Association of Towns has stated it is not advisable for the Town to issue a building permit on seasonal roads.
- Senior Trip- The next Senior trip is scheduled for September 26th to the Stanley Theatre to see "Hello Dolly." Cost is \$20 for Forestport taxpayers and \$75 for Seniors outside of Forestport.
- 2019 Budget: This is in progress.

Tracy Road. There are a couple ways in which a Town can continue plowing theses roads, but the Town of Forestport does not meet the criteria. In the case of an emergency, the Town has the authority to plow the roads. Discussion took place. Supervisor Entwistle read the Resolution aloud. A copy of a letter and the resolution will be mailed to each homeowner on the roads listed above. Any questions regarding this matter can be directed towards Supervisor Entwistle.

- Mr. Romeo from the gallery asked if Maple Road, behind White Lake Inn was going to be repaired. Supervisor Entwistle stated Maple Road will be fixed next Spring.
