### **OLD BUSINESS BOARD:**

- The 2019 Budget has been filed with the County.
- Building Permits on Minimum Maintenance Roads: Supervisor Entwistle has received a draft Law from the Town of Florence. If the Town allows a resident to build on a minimum maintenance road, it becomes the Town's responsibility to maintain the road year round. Supervisor Entwistle has sent the draft to Attorney Riley to format to the Town of Forestport's Site Review Law. It will be under Article 5 Section 1 and "Seasonal Use Residency" and under Appendix A, there will be a definition of a Seasonal Use Dwelling. Discussion took place.
  - ➤ Councilman Rockhill suggested looking into Tiny Houses as well. This is something that is happening in other States and will likely be something residents may be doing here.
- Firefighter Cancer Benefit: Most firefighters thought the State was providing this benefit, but they are not. Supervisor Entwistle is finding out how many firefighters are in each department that qualify and what the Town can do to help. Discussion took place.

### **NEW BUSINESS BOARD:**

- Ambulance: Supervisor Entwistle met with Kevin Revere, from the 911 center in Oneida County. The 911 Center is looking into the option of a second Ambulance through StaR Ambulance to be stationed somewhere in Forestport. Discussion took place.
- Local Law to change Escrow Fees from \$100 to \$250:
