OLD BUSINESS BOARD:

- Bear Creek Lodge Roads: Deer Hollow Road and Hemlock Road. Supervisor Entwistle has been invited to attend their meeting on Saturday at 7pm. They have given the Bear Creek Lodge membership all the information they needed. Bill Gardner estimates it will cost \$20,000-\$25,000 and it would take place next year if they decided to have the Town taken them over.
- Buckhorn Roads paperwork is nearly completed. The Highway Department has started rolling, taken trees down and the roads will be rolled this year. Mr.
 Candido stated it is great to be able to drive down their roads with golf carts and vehicles.
- DelMedico Property: The Town has been trying to bring the property up to codes or get it demolished. The Supervisor was finally able to get a hold of somebody and the Board has decided to have the property transferred in the Town's name for \$1.00. The Town will be responsible for back taxes owed. Supervisor Entwistle Spoke with Mrs. DelMedico and they have a meeting at 10am at the Town Hall Friday.
 - ➤ The Demolition is going through regardless if they hand the property over to the Town or not.
- The Town is switching payroll services from ADP to Adirondack Bank. July 3rd will be the first check to go through.
- STEM Program: Erin Burns has written the program and cleaned the Woodgate School up. Councilwoman Kardash asked if the numbers for the program drop, is the Board going to consider dropping the Program. Adirondack School has sent applications for the Boonville Summer Recreation home with the children in Forestport. Supervisor Entwistle said the Town might have 11 or 12 kids signed up. They will have one Teacher and one Assistant and will continue with the Program for the children signed up.
- Old Forestport Days: The Town in conjunction with Jeanne Wolcott are running a Contest this year for Old Forestport Days next year. They are designing a logo and currently have two entries.
 - As a fundraiser, they are looking for photography pictures from around Town.

- Jeanne Van Valkenburg discussed the Solar Power. Supervisor Entwistle stated the only thing the Town has done regarding Solar Panels is a Local Law on taxing Solar Farms. She commended the Town on the work they did on Moose River Road.
- Forestport Fire Department will be doing their steel drive in conjunction with the Town Dump Day.
- Supervisor Entwistle stated he was present at the Planning Board meeting last week and spoke with Dave Vandewater. He initially contacted Supervisor Entwistle to see if they could use the driveway to the Pierce property well so they could show the property. At the Planning Board meeting, what they were really after is to permanently use the fee road as an access road for one of these lots. He stated he doesn't have an issue with it. Supervisor Entwistle read a letter aloud from Andrew Bailey, the Surveyor stating the deed restrictions. The letter is on file in the Town Clerk's office.

Supervisor Entwistle stated he would like to see in there the Town has no responsibility in plowing it. He tried getting a hold of the Attorney, Bill Riley and wasn't able to. Councilman Scouten said his concern would be the Fire Department getting there. Supervisor Entwistle said the owner would responsible for plowing all the way to River Street. Councilwoman Kardash stated this is still a Planning Board decision and the Town is trying to get out of the road business and she isn't sold on the idea. Supervisor Entwistle stated the Town Board needs to grant permission for them to go off the Town's fee Road. If the person who buys this ends up selling, the lot needs to be deeded forever to the next person. Arthur Gleasman, from the Gallery stated it is an illegitimate lot.. Jeanne VanValkenburg asked how big the lot is. It was answered 41.43 acres.
