Mr. Gonzalez has purchased a 4 acre property; touching on the river. He is
interested in finding out what it would cost him if the Town could extend the
water district by contract. Jack Dodson said the existing 4 inch diameter water
main terminates 150 feet from centerline of the dwelling unit. Ballpark cost to
extend the 4 inch main with waterline end to house is estimated at \$15,000\$20,000 another estimate is 85 feet with hydrant and extend water service across

property \$10,000-\$15,000 assuming a local Contractor is hired. Jack Dodson gave his recommendation. Supervisor Entwistle stated he would like to decline the contract. The project would have to be contracted through Jack Dodson and overseen by Ted Daktor and Jim Pelno.

Kratzy's: Several months ago, the Board voted to waive the overage fees as an error for Kratzy's Bar and Grill. The Overage fees are still on there. The water billing clerk stated she is not taking the overage fees off and Supervisor Entwistle

stated she is going to.

• Pierce Property Subdivision: The Surveyor and Land Developer are facing issues with lot frontage. The lot was originally subdivided in 2015. The original parcel was in the Water District. Supervisor Entwistle stated if the original lot is in the water district, they only need 100 feet of road frontage. It would also affect the Town because since the 2015 subdivision, Dawn as the Water billing Clerk was unaware the one parcel became three. If it is confirmed in the Water District, they are creating a 4-lot subdivision out of a three lot subdivision. Supervisor Entwistle stated the Subdivision hasn't been officially approved.
