- 2020 Forestport Celebration; next year is the 150th birthday for the Town. A committee has formed and are raising money to make next years celebration a big deal. They put a bid out for the 2020 logo and Stephen Fletcher is the Official Logo winner. The Town has committed to \$150 for the winning logo. The Committee will be selling Calendars in the Fall. Nature Photos were submitted for the contest and Karen Spine, Adam Daktor, Jeanne Wolcott, Tina Olds, White Lake Lodges and their Photography staff were the winners.
- Dump Day was July 20th and it was a success. Supervisor Entwistle thanked the Forestport Fire Department for doing the steel drive in conjunction with the Town Dump day.
- 12216 Woodhull Road: The condemned house has been demolished and Willie Van & Sons did an excellent job with the demolition. Unfortunately, their bid of \$11,800 was under because they were unable to go inside of the building prior to the bid.

- Bear Creek Lodge Roads: The Town is currently in negotiations with Bear Creek Lodge to have them turn the roads over to the Town. Supervisor Entwistle is hoping to hear back from them by September 1st because if they cannot come up with a decision the Town will have to pass a Resolution to not continue plowing this Winter. Lance Hoffert asked if the Association had to bring the roads up to specs first and it was stated the Highway Department will be doing the work, but it will be a homeowner's expense; if they choose to go that route.

• Forestport Elementary School: As of today at 4pm Supervisor Entwistle spoke with Natalie Roth, with Benn Realty who is representing the Town. She has been

- in contact with the Listing Agent and told him the Town of Forestport would like the ability to offer their best and final offer over anyone else and he said he would be willing to take that back to the School Board. Discussion took place.
- There is a family in Town that had a tragedy and are tentatively coming to the Town for a low interest loan for HUD money. There is approximately \$43,000 in the HUD account.
- Highway Contract negotiations- They are currently negotiating the 2020-2022 contracts and it is going smooth. They will meet again August 27th at the Town Hall.
- Budget Season dates: September 24th and October 1st will be budget hearing workshops at the Town Hall at 6:30. The Hearing for the Preliminary Budget will be October 29th at 6:30. The Preliminary Budget will be on file at the Town Clerk's office and on the website.
- The Town has been approached by a company that is in the preliminary stages of a large project. It is going to be a very controversial project. They are currently projecting 600-800 acres of solar panels producing 150 mega- watt of power. The Planning Board Meeting will be September 10th at 6:30pm at the Town Hall.
- Trackside Blazers has submitted a bill for repairs to the Groomer the Town purchased for the Snowmobile clubs use. The estimate is for schedules maintenance for \$12,000. Ron Davies, the President of Trackside Blazers and Supervisor Entwistle have discussed this. There is \$9,000 in the Budget for this. They are speaking with the Town Grant writer to get grant money for grooming, maintenance and the possibility of a new groomer in the near future.

• Boat Wash Station: The Boat Wash Station on Route 28 at Okara Lakes has been moved up in the Northern Adirondacks. Forestport's greatest resource is the waterways. There are more than a dozen letters from organizations for the Town to do a grant for a Boat wash station in the Town of Forestport. If the Town gets the grant and the School, the boat wash station will be located there. The grant money could include the equipment necessary, storage facility and labor to run it up 5-6 days a week for 12 weeks. Luanne is a member of the White Lake Association and has worked diligently trying to bring groups of associations together to try to battle this. Otter Lake has some algae blooming this year. Luanne said the Finger Lakes have some sort of invasive species. It's better to be preventative. It ruins the ecology. If the Town were to move forward with this

grant application, and if the town could afford to run it for 3-4 years, the State would take this over and be their responsibility after that. Lance Hoffert stated he was speaking as a taxpayer and a year round resident, asked why the Town would move forward with this grant, when people can't go to White Lake. It was mentioned all the lakes in the area would benefit from the boat wash station. Supervisor Entwistle stated the Lake Associations are not a 501c3 Organization and need a Municipality or a 501c3 company to do the application. Councilman Scouten asked if the School falls through does it have to be on Town property and it was answered yes. The backup location would be the Highway Barn.
