OLD BUSINESS BOARD:

- **Horton Road Bridge:** Supervisor Entwistle spoke with the Engineer and they are slated to be finished for the end of the month.
- Code Enforcement Officer: Applications are being taken until the first of November. The individual has to be highly organized, computer savvy, construction background, can work flexible hours. They are not interested in anyone that has a full time job. It was asked if it had to be Civil Service and it was answered no, because they are Part Time.
- **Site Review Law Changes:** There were changes to the signage and the fee structure. There is a waiting period once it is filed with the State.
- **Bear Creek Lodge Roads:** The Board is very close to passing the Resolution. The Town is in the process of taking over the three roads in Bear Creek Lodge Roads. Deed releases were required and out of 39 members, they are down to one

member. This should be taken care of next month.

- **Budget Season:** The Budget Workshops are being held on September 28th and October 5th both at 6:30 at the Forestport Town Hall. September 28th will be the General, Water and Sewer and October 5th will be the Highway and the Fire Budget. Supervisor Entwistle highly encourages the public to attend.
- Ambulance: The Town is considering adding a tax line to the tax bill to fund the Ambulances further than they are funded now. There would be two separate line items for the Ambulance and the Fire. Councilwoman Kardash stated she would like to lower the amount a little more to fund the Fire Department.

A motion was made by Councilman Scouten and seconded by Councilman Scott to move forward and put a tax line item on the Forestport Tax bills to fund Old Forge Ambulance and StaR Ambulance.

• Supervisor Entwistle stated, in 2011 Governor Cuomo enacted the 2% Property Tax cap. Since then, the Town of Forestport has stayed within that. The Town of Forestport cannot continue for 2021. With the idea of adding an ambulance line, they would be breaking the tax cap anyway. The Boards has discussed this briefly at a workshop a couple weeks ago and they all feel like they have to find a way to increase funding to the fire departments and everything continues to go up. They are investigating the possibility of overriding the tax cap.

A motion was made by councilwoman Kardash and seconded by Councilwoman Abrial to schedule a Public Hearing for October 21, 2020 for the Local Law regarding overriding the Tax cap at 6:15pm.

It was asked if there were any penalties for overriding the Tax Cap. Supervisor Entwistle stated the only penalty is the Taxpayers won't get a check for the Town staying within the Tax Cap. Town of Forestport taxes were 1.70/1,000. Boonville is 1.36/thousand. This quarter's sales tax is going to be down approximately 25%. The Town has managed to keep the Tax rate flat. Taxes went way up in 2008 because of the revaluation and the money that was put into savings. The Fire Budgets and Ambulance Contracts have been

frozen for years. Tax rates have stayed low, but the most important services are suffering.

NEW BUSINESS BOARD:

Cemetery Road: The Town has discovered there is 16 acres on Cemetery Road. The Assessor said it's worth approximately \$16,000. The Board discussed it and decided they would put it out to bid. Supervisor Entwistle read the resolution aloud.

A motion was made by Councilman Scott and seconded by Councilman Scotten to sell the land on Cemetary Road.
