- **Bear Creek Lodge Roads:** The Town has received all deeds for Deer Hollow Road, Perch Pond Road and Hemlock Road. Mr. Riley, The Town Attorney will be filing them with the County Clerk. Supervisor Entwistle will be sending an Official letter to Bear Creek Lodge letting them know it's official.
- **APEX Grant Application:** The Town has applied for a grant through Alder Creek Solar for \$1500 towards the Recreation Program. The Town has an application out and are waiting to hear back.
- Codes Enforcement Official/Planning Clerk: The Board interviewed three candidates this evening. There have also been some applicants for the Planning Clerk. A decision will be made on that in the coming weeks.
- Office Rental: Currently the Dot and Slate Hill Constructors are renting an office for the Adirondack Railroad Project. Luck Brothers are contracting for the Route 28 overpass in the Spring. They are looking to rent office space as well in Mid-December. Supervisor Entwistle has sent them a building use agreement and let them know about the rent.
- Year End / Organizational Meeting: The Year End meeting is December 29, 2020 at 11am and the Organizational Meeting is January 5, 2021 at 6:30pm.
- **Trackside Blazers Contract:** Supervisor Entwistle signed the yearly Contract. A copy of the contract will be given to Trackside Blazers. Supervisor Entwistle stated to Ron Davies, the President of Trackside Blazers that he is still addressing concerns he brought up at last month's Meeting. Right now, he doesn't have any answers. Ron stated he doesn't understand the issue. Discussion took place.
