## **CALL TO ORDER:**

We would like to thank all of our member towns and villages for your continued support. NOCCOG remains committed to providing services to all of our 17-member municipalities. We hope the impact COVID is having on our communities will soon be over so we can return to business as usual.

Attached, please find the NOCCOG IMA last renewed in 2015. This agreement, by law, runs for five years, and it is time for renewal. We are asking our member communities to review the IMA and act on the resolution below before April 1,

WHEREAS, the town/village of Form of reaffirms that continued membership in NOCCOG is important to both the town/village and the region, and

WHEREAS, NYS General Municipal Law Article 5-G requires that any intermunicipal agreement be renewed within a five year period.

BE IT RESOLVED, that the town village of FORMSTPORT approves renewing the intermunicipal agreement, and be it further

RESOLVED, that a copy of this resolution be transmitted to NOCCOG for its records.

At the NOCCOG executive board meeting on December 17, 2020, the board agreed to approve a one-year contract with Joe Rowlands in light of the fact that associate contractor Harlan Moonen would not be renewing his contract as of January 1, 2021. As an associate contractor, Joe could no longer serve on the executive board so he resigned his position on the executive board effective December 31, 2020. This left a vecancy on the executive board, which Ed Davis has agreed to fill as a director. Ed lives in the town of Lee and is very familiar with NOCCOG. He is the Lee planning board chair, is involved in the town fire department, and has been active in town government for many years.

NOCCOG bylaws state that any vacancy that occurs on the executive board shall be filled by an election at a special meeting or by mail ballot. Since we are not able to hold a special meeting due to COVID, we are requesting members to cast their vote to fill this vacancy on the executive board by email ballot. • Lightning on White Lake/Old Forestport Days Road Closure: Brian Albert requested a Public Hearing for his annual Block Party.

• **Dog Enumeration:** The current fees are \$5 if your dog is neutered/spayed and \$15, if they are not. Some Towns do three- year rabies licensing. It makes it simpler for dog owners and the Town; as rabies vaccinations are generally 3 years. There are a lot of dogs in Forestport that are not registered. It is very helpful for the Dog Control Officer when a dog is missing, and he has to try tracking down the owner for rabies vaccinations. Supervisor Entwistle will be talking to Craig Jenks, the Dog Control Officer.

- **NYS DOT:** There is a Bridge project over Forestport Pond and the overpass over Woodhull Road. Route 28 will be closed April 1 until June 25. There is a \$10,000 a day fine for every day they are late. The overpass is going to be completely replaced.
- **Dodge Pratt Northam:** Joanne Ballard is working on a project where they pair up seniors who are unable to visit the doctor in person; COVID-related with Tele-Health visits. She would like the Town to allow them to host the program at the Town Hall with a room. They would be setting Seniors up with a laptop to talk to their Physician; Supervisor Entwistle let her know the Town did not have an extra laptop. Joanne is going to try getting a laptop dedicated to that and will keep Supervisor Entwistle posted.
- **American Relief Bill:** Congress has directed money to small municipalities. The Town of Forestport is slated to receive \$174,000-\$175,000.
- Sheds: The Codes department is having a huge influx of inquiries on premanufactured sheds. People are calling for a shed permit and are saying they are going to live in them. Sheds are not camps or bunkhouses. Supervisor Entwistle reached out to the Snowbird Lake Association and will be sending him a cheat sheet as to what constitutes as a tiny house. The Code Enforcement officer is going to be checking the sheds. If they are caught, they will be ticketed immediately. An RV cannot be used for more than 30 days in a calendar year. It's one RV per household; two RV's becomes an RV Park.
