## **OLD BUSINESS BOARD**

- **Bear Creek Lodge Roads**: The Highway has removed trees and grated and rolled the roads. The roads will be stoned and oiled next year.

## **NEW BUSINESS PUBLIC:**

- **Highway Uniforms:** The Contract with Aramark has expired and Aramark is trying to get the Town to do a 4-year contract. The Highway Department has had issues with the company. Supervisor Entwistle has looked into purchasing safety t-shirts, Dickie's workpants and Carhart full zip sherpa hoodies. The startup cost would be no more than \$3,870. The replacement of all t-shirts, 4 pants and hoodie would be \$3,000 a year, if needed. Mr. Rowlands, from the gallery stated his Town has eliminated a uniform company and worked out a deal with Holland Patent Co-Op for the Dickies. Holland Patent Co-Op personally sends the vouchers to the Town. Supervisor Entwistle stated he will call Holland Patent Co-Op.
- Tree removal: There is a tree hanging over a neighboring garage and car on the vacant lot at 12216 Woodhull Road. Supervisor Entwistle asked Kody Smith, of To the Top Tree Care to take the tree down. Kody is charging \$800 and Jim and Matt will cut the tree up once it's down.
