

RESOLUTION OF THE TOWN BOARD OF THE
TOWN OF FORESTPORT, ONEIDA COUNTY,
NEW YORK, AWARING FRANCHISE FOR
CLOSED CIRCUIT TELEVISION

WHEREAS, Lewneida Cable T.V. Co., Inc. has applied for a franchise to operate a community antenna television system in the Town of Forestport, Oneida County, New York, through the usual and customary media of cables and/or wires, etc., commonly called a master cable antenna system or otherwise, and

WHEREAS, they desire in such franchise to secure the permission of and authority from the Town of Forestport for the use of its streets, highways and public lands for such purpose, and

WHEREAS, Lewneida has filed with the Town Clerk of the Town of Forestport proposed rates and charges to subscribers in said Town as dated June 1, 1965, and

WHEREAS, the Town Board of the Town of Forestport has heretofore duly called and noticed a public hearing on said application for Wednesday, March 2, 1966, and

WHEREAS, at said public hearing, another proposal was orally presented and considered by said Town Board, and

WHEREAS, said Town Board has determined that it is in the public interest to grant the requested franchise of Lewneida Cable T.V. Co., Inc. upon its application and upon the understanding that any such franchise is not exclusive, and

WHEREAS, said franchise is to be conditioned upon the continued payment to the Town of Forestport, during the life of said franchise, of 2.25 per cent of the gross rentals of Lewneida to the community,

NOW, THEREFORE, BE IT RESOLVED, that the Town of Forestport, Oneida County, New York, does hereby grant to Lewneida Cable T.V. Co., Inc. a non-exclusive franchise, cancellable at any time by the grantor upon expiration of twelve (12) months following six (6) months notice, to operate a community antenna television system within the geographical boundaries of the Town of Forestport, N.Y., which franchise shall allow the Lewneida to use the streets, sidewalks, public lands and highways of said Town for the conducting of its

system, and be it further

RESOLVED, that said franchise is conditional upon payment to the Town of Forestport of 2.25 per cent of the gross rentals to the community by Lewneida (not, however, including installation service or relocation charges), and be it further

RESOLVED, that it is contemplated that Lewneida will charge to the local community residents in accordance with the proposed charges to subscribers heretofore filed by Lewneida with the Town Clerk of the Town of Forestport and that the Town shall be advised of any changes therefrom within thirty (30) days of the effective date of any such change; said rates and charges to not, however, be a term or condition of the granting of this franchise, and it is further

RESOLVED, that there shall be no obligation or expense on behalf of the Town of Forestport in connection with the granting or exercise of this franchise by the applicant, Lewneida.
