

RESOLUTION

WHEREAS, the Town of Forestport wishes to assist lower income families, elderly and handicapped residents in obtaining affordable, decent, safe and sanitary housing; and

WHEREAS, the Housing and Community Development Act of 1974, Title II, S201 (a)(8)(b) authorizes the Secretary of the Department of Housing and Urban Development to enter into annual contributions contracts with public housing agencies for the purpose of making rental assistance payments to owners of decent, safe and sanitary housing on behalf of lower income, elderly and handicapped persons; and

WHEREAS, the Town of Forestport possesses the necessary authority under the laws of the State of New York to participate in this program as a public housing agency (PHA) defined by the Housing and Community Development Act of 1974, Title II, S201 (a)(3)(part 6) as any State, County, municipality or other governmental entity or public body (or agency or instrumentality thereof) authorized to engage in or assist in the development or operation of low-income housing; and

WHEREAS, the Department of Housing and Urban Development has stated in CFR Part 882.103(c) that preference in funding will be given to PHA's which provide the broadest geographic choice of housing units; and

WHEREAS, to prevent duplication of effort and promote the greatest possible efficiency of administration, the Town of Forestport may enter into cooperative agreements with other municipalities in Oneida County under the laws of the State of New York.

WHEREAS, the municipalities of the Town of Forestport, the Town of Ava, the Town of Boonville, the Town of Deerfield, the Town of Lee, the Town of Western

have by resolution authorized the Town of Forestport to be the Section 8 Existing Housing Program operative within the territorial jurisdiction of the above stated municipalities as well as in the territorial jurisdiction of the Town of Forestport.

BE IT

RESOLVED, that the chief executive officer of the Town of Forestport is authorized to prepare, execute, and submit to the Department of Housing and Urban Development an application and all other documentation which is or may be required to implement the purpose of this resolution; and be it further

RESOLVED, that the PHA of the Town of Forestport agrees to the entering into of a contract with the Oneida County Community Action Agency, Inc. within the limitations of pertinent State and

Federal laws for the administration of a Section 8 Housing Assistance Payments Program for Existing Housing pursuant to Title II of the Housing and Community Development Act of 1974.
