BE IT RESOLVED that the Town Board of the Town of Forestport finds that all property and property owners within the proposed extension are benefited thereby, and

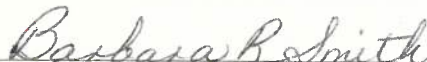
BE IT RESOLVED that the Town Board of the Town of Forestport finds that all property and property owners benefited are included within the limits of the proposed district and district extension, and
