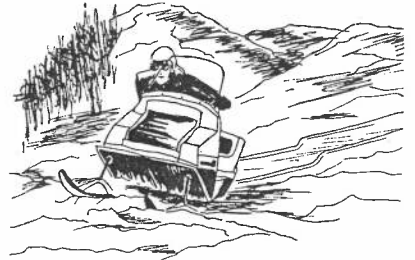

The following motion was duly moved, seconded, and adopted:

WHEREAS, the Board of Legislators of the County of Oneida has issued a certificate to the Chief Fiscal Officer of the Town/City certifying that the contribution of the Town/~~CITY~~ of FORESTPORT to the taxes of the County of Oneida for the fiscal year beginning January 1, 1986 is \$ 245,556.52, and

WHEREAS, the Town/City must levy said sum against the taxable real estate and direct the extension of such taxes against each such parcel, now, therefore, be it hereby

RESOLVED,

1. The Town Board/City Council of the Town/City of FORESTPORT does hereby levy the sum of \$ 245,556.52 certified to it by the Board of Legislators as said Town/City's contribution to the taxes of the County of Oneida for the fiscal year beginning January 1, 1986.

2. The taxes due the County of Oneida shall be extended against each parcel of taxable real estate at the rate of \$ 118.48 per \$1,000 of taxable assessed value.

3. The Chief Fiscal Officer is hereby directed to execute and deliver a certificate to the Board of Legislators of the County of Oneida certifying that the levy has been made and the extension of taxes directed in accordance with law.

SUBJECT: 1986 COUNTY TAXES

In accordance with the provisions of Chapter 828 of the Laws of 1985, the Oneida County Board of Legislators has adopted a budget for the fiscal year 1986. The Board has directed the Chairman of the Board of Legislators to issue a certificate certifying the contribution of your town or city to county taxes and the rate per \$1000 of taxable assessed value.

Under the law, the Town Board or City Council must levy the tax and authorize the extension of taxes at a rate which will exactly equal the amount certified to be due. They must complete their action by December 10, 1985.

For your use there is enclosed herewith a proposed resolution adopting the levy and a proposed certificate to be returned to the Board of Legislators.

The Chief Fiscal Officer of the town or city must execute and return the certificate from the town or city to the Board of Legislators by December 15, 1985.

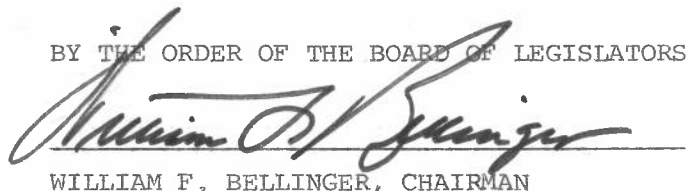
