SUBJECT: AUTHORIZATION FOR PARTICIPATION BY THE TOWN OF
FORESTPORT IN THE LOCAL BRIDGE PROGRAM OF THE NEW YORK STATE
DEPARTMENT OF TRANSPORTATION.

WHEREAS, Pursuant to Chapter 836 of the Laws of 1983 and Article 17 of the Transportation Law, The New York State Legislature has authorized and appropriated funds for a LOCAL BRIDGE PROGRAM to be administered by the New York State Department of Transportation, and

WHEREAS, The TOWN OF FORESTPORT desires to participate in this program, now therefore be it

RESOLVED, That the TOWN OF FORESTPORT is authorized to participate in the LOCAL BRIDGE PROGRAM, pursuant to the terms of the Bond Act, the Program Guidelines and the New York State Agreement which the TOWN OF FORESTPORT hereby ratifies and affirms, and be it further

RESOLVED, That the accomplishment of all local bridge projects authorized under the LOCAL BRIDGE PROGRAM shall be by the competitively let contracts administered by the ONEIDA COUNTY DEPARTMENT OF PUBLIC WORKS, and be it further

RESOLVED, That upon completion of this program, the TOWN OF FORESTPORT shall at its own expense properly maintain all Local Bridge Program improvements to the bridge(s) listed in Schedule 'B' to the extent that they will remain off the deficient bridge list for at least ten years, and be it

RESOLVED, That the SUPERVISOR be and is hereby authorized to execute all necessary agreements and documents on behalf of the TOWN OF FORESTPORT that are required by the New York State Department of Transportation for participation in the Local Bridge Program, and be it further

RESOLVED, That the Town Clerk shall transmit two (2) certified copies of this resolution to the Division of Engineering, of the Oneida County Department of Public Works
