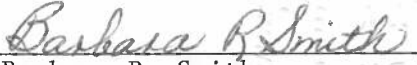
At a Regular Town Board meeting of the Forestport Town Board,

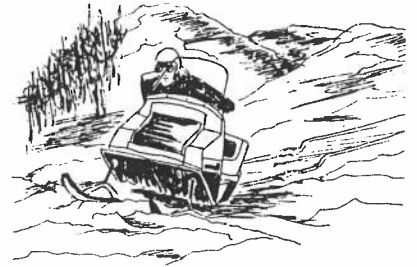

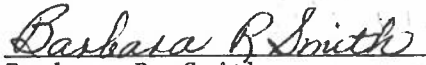
