RE: REQUESTING ABANDONMENT OF ADJACENT BRIDGES (BIN 2205710 AND BIN 2205720) OVER THE
BIG WOODHULL CREEK ON MEEKERVILLE ROAD IN TOWN OF FORESTPORT

WHEREAS, The County Commissioner of Public Works has inspected the adjacent bridges, Bridge No. 2205710 with a span of twenty-four feet and Bridge No. 2205720 with a span of sixty-six (66) feet, which are located over the Big Woodhull Creek on the Town of Forestport highway known as Meekerville Road, extending from Woodhull Street easterly to Meekerville Road South and has certified under date of November 17, 1987 to this Board that such bridges have become useless and not necessary for the public's convenience and welfare and has recommended their abandonment for the reason that there is a general deterioration of said bridges and by reason of the fact that access to Woodhull Street and Meekerville Road South is provided by adjacent highways, and

WHEREAS, The Town Board of the Town of Forestport has adopted a Resolution dated November 12, 1987 finding that said bridges have become useless and not necessary for the public's convenience and welfare, now, therefore, be it hereby

RESOLVED, That to promote the interests of the County and pursuant to Highway Law, Section 231 Subdivision 12, the County Commissioner of Public Works is hereby ordered and directed to abandon such adjacent bridges over the Big Woodhull Creek located on Meekerville Road in the Town of Forestport and to erect suitable barricades for closing such bridges and to erect suitable signs in relation thereto as are prescribed in the Highway Law, and be it further

RESOLVED, That the Clerk of this Board shall serve a certified copy of this resolution on the County Commissioner of Public Works and said Commissioner shall make, in duplicate, a written order of abandonment for each bridge and file one order for each bridge in his office and one order for each bridge in the office of the Clerk of this Board who shall make and file certified copies of this Resolution and of each such order in the office of the Town Clerk of the Town of Forestport and shall mail two certified copies of such Resolution and each such order to the State Department of Transportation.
