

AGREEMENT BETWEEN THE COUNTY OF ONEIDA AND THE TOWN OF Forestport FOR THE MOWING OF COUNTY ROADS.
THIS AGREEMENT, made this <u>lith</u> day of <u>May</u> , 19 <u>88</u> by and between the County of Oneida, hereinafter called "County" acting through <u>Michael J. Zane</u> , Deputy Commissioner, County Department of Public Works, and the Town of <u>Forestport</u> , County of Oneida, State of New York.
WITNESSETH: that for the consideration and upon the terms and conditions hereinafter provided the Town agrees to furnish all machinery and labor therefor and to keep Right of Way portions of the highways mowed in accordance with the rules and regulations as set forth by the County and which are made a part of this contract for the summer season dating from May through September of this year.
It is further agreed that the Town Board of said town by resolution accepts the proposal of the County of Cneida for roadside mowing on the improved County Road System of said town with the additions noted hereunder; a total of $15.37$ miles for the sum of $\frac{100.00}{100.00}$ per mile, totaling $\frac{1.537.00}{100.00}$ , one half of which shall be paid said town on or about the first of June and the balance upon completion of final mowing, not later than October first.
ADDITIONS
IT IS FURTHER AGREED that the Town will mow said roadsides a total of three times as specified below:
<ol> <li>The first shall be one pass to the ditch and around all intersections and driveways.</li> </ol>
<ol> <li>The second shall include all of the County Right of Way where practical.</li> </ol>
3. The third pass shall be optional and will involve one pass to the ditch and around all intersections and driveways. The need for a third pass will be determined by the Deputy Commissioner of Highways & Bridges.
