WHEREAS the Town of Forestport having no sewer district in existence within the stated boundaries of the alleged problem areas and

WHEREAS the Town of Forestport recognizes the capacity of Oneida County Community Action Agency, Inc. to secure available funding for low income families within the established problem area, and to assist with the financial burden on these residents, we therefore

RESOLVE to encourage Oneida County Community Action Agency, Inc. to apply for funds from any, or all, available funding sources to assist the eligible individual residents of this problem area within these boundaries, and

BE IT FURTHER RESOLVED THAT the Town of Forestport certifies that since there is no recognized, defined or established sewer district in existence in the Town of Forestport, there are no tax monies available to support this program, and therefore the Town will not be spending any funds in substitution of funds received through Oneida County Community Action Agency, Inc. for this specific project.
